1 HAND-TO-HAND COMBAT (RUKBO) SINGLE CHAMPIONSHIPS

1-1 PERIODICITY / AGE GROUPS

During the CSIT World Sport Games the age and weight categories are as follows:

Age and weight categories

Discipline: **SELD-DEFENSE** (Male and Female in separate categories)

Discipline: **KUMITE SEMI CONTACT**

1-2 ORGANISATION / REGULATIONS

CSIT Hand-to-Hand Combat Single Championships are are opened to all karate styles and other types of martial arts

HHCF accepts Self-defense of all karate styles and other types of martial arts

1-3 COMPETITION FORMAT

Competition system can be elimination system with repechage or round robin (matrix) system. Selection of the system will be based on number of registered athletes and will be defined for each category separately after registration.

Eliminations system exists of;

- Eliminations round
- Repechage
- Bronze medals bouts
- Finals

The round robin (matrix) system is explains as follows:

Each competitor gets a number defined by draw. In case of odd number of competitors the last competitor in each round is free

Championships cannot last more than five (5) days (days of arrival and departure not included).

1-4 OVER CLASSING

No over classing is allowed. Neither in weight nor age categories.

Age categories are defined on the year of birth (see TC & Championships General Regulation – Chapter 4)

2. PARTICIPATION CONDITIONS

2-1 PARTICIPATING TEAMS

More than one team per gender per Union can participate



2-2 NUMBER OF PARTICIPANTS

- 1 Head of delegations
- Coaches
- Referees (obligatory for each team with 4 or more members*)
- Unlimited number of competitors

* Additional information can be found in section 6 refereeing

2-3 ELIGIBILITY CRITERIA

Professional athletes cannot participate in CSIT Hand-to-Hand Combat Single Championships.

Reference date is 10 days before the individual CSIT championship or WSG.

3. FAIR PLAY

CSIT championships are organized according the principals of Fair Play.

During CSIT Championships athletes, persons and teams can be awarded for acts of Fair Play. Fair Play regulations can be found in the CSIT Technical Commissions and Championships General Regulations edition 2016 and later, Chapter 5.

4. REGISTRATION / FUNDING

4-1 REGISTRATION DELAY

- Provisional registration: at least four (4) months before the championship starts.
- Final registration: at least two (2) months before the championship starts.
- Final registration must include the list of all delegation members (first name - last name - birth date - gender - function)



4-2 COVERING CHARGES

Unions pay for all travelling cost to the city where the championship is organized (round way).

The organizer Union shall take charge of the following issues:

- Transportation of delegations from the airport or train station to the hotel on the day of arrival and departure
- Local transportation during the stay depending on the program (between hotels and sport facilities in particular)
- Full board accommodation (e.g. double room, breakfast, 2 meals a day)

Every participant Union shall pay a registration fee as determined at the latest CSIT Congress to the organising Union for each member of the delegation.

By the time of issuing of the provisional application forms, the organizer Union can collect an advance payment of 50% of the total amount to be paid by the participating Union, the remaining amount being paid at the time of the permanent registration or on the day of arrival, final deadline.

4-3 CANCELLATION POLICY

CSIT has a cancellation policy. This cancellation policy covers the payments at preliminary and final registration and the refund payments by cancellation of a participating party or by the host of the championship.

The article in detail can be found in Chapter 4. under I of the Technical Commissions and Championships General Regulations.

5. ORGANISATION / PREPARATION

5-1 ORGANISING COMMITTEE

The organising committee by the host is in charge of the preparation and organisation of the championship. The CSIT Technical Commission and a representative of the organising committee are in charge of the management of the championship during its duration. See Chapter 4 under E of the Technical Commissions and Championships General Regulations.



5-2 INVITATIONS

The organising committee sends championships invitations to every CSIT Union (and partners), company sports organisations and guests etc. at least nine (9) months before the start of the championship. Invitations must include this information:

- Participation.
- Sporting activities, social and cultural program.
- Referees needed.
- Boarding facilities.
- Arrival and departure accommodations.
- If possible, general program.

Detailed information can be found in Chapter 4 under D of the Technical Commissions and Championships General Regulations.

5-3 PREPARATION

Depending on the situation and with the CSIT Sports Director's authorization, a member of the Technical Commission (chairman or secretary) can visit the location where the championship is organised, at least three (3) months before it starts, to settle with the organising Union planning and preparation of the championship. Travelling expense can be covered under certain conditions by the funds awarded to the Hand-to-Hand Combat Technical Commission by the CSIT.

5-4 REPORT

Within seven (7) days after the Championships the secretary of the Technical Commission will send the results of the Championship to the Sports Director and office of CSIT. No later than one (1) month after the end of the championship, the Technical Commission secretary must send a report about the championships and all the sport results plus the minutes of the TC meetings to the members of the Technical Commission, to the Unions, to the Sports Director and to the office of CSIT.



6. REFEREEING

The engagements are arbitrated according to the rules of arbitration of the HHC (RUKBO) in application during the sporting season in progress.

Only referees with at least a valid national HHC (RUKBO) licenses can arbitrate in the competition in order to ensure a quality refereeing, smooth running of the competition and safety of the competitors.

All referees have to attend a Referee Briefing which will be organized before the competition.

Minimum 12 referees per tatami is required for a good progress of the competition.

The referees are registered by the Unions. Each Union should provide 2-4 referees. Unions who do not apply this rule must pay the organiser Union an amount specified in CSIT regulations to cover substitute referees' fees.

The organizing union should bring enough referees to ensure required minimum number of referees, depending on a number of competition areas (tatamis).

Referees must be official referees of their own Union with national or international HHC (RUKBO) license. If necessary, a Union can contact referees from its country National Hand-to-Hand Combat (RUKBO) Federation.

7. APPEAL COMMITTEE

- The Appeal Committee is composed of:
 - The CSIT Technical Commission's chairman
 - The CSIT Technical Commission's secretary
 - A person among the participating Unions. Such member shall not participate in the appeals in which his own Union would be involved.

- An appeal committee is appointed for every championship in agreement with WKF regulations.

- Appeals for technical reasons must be brought to the attention on the appeal committee no later than one minute after the end of bout and then the coach has 4 minutes to fill out the form, providing all the necessary information.



Detailed information can be found in Chapter 4 under L of the Technical Commissions and Championships General Regulations.

8. AWARDS

The individual participants (in all categories) will be awarded as follows with metals: gold for the first place, silver for the second place and bronze for both third places.

In case of team competition, the first three (3) teams will be awarded a cup and a medal for each team member: gold for the first place, silver for the second place, bronze for both third places.

A participation certificate and a medal will also be provided for the referees

Detailed information can be found in Chapter 4 under M of the Technical Commissions and Championships General Regulations.

Additionally, athletes, persons and teams can be awarded for acts of Fair Play, as stated in section 3.
